# OBERER THOMPSON COMPANY FINALIZES SITE WORK PREPARATIONS AT CORNERSTONE DEVELOPMENT

Oberer Thompson Company has substantially completed site-preparation efforts at the Cornerstone Development – a 150-acre area of land located at I-675 & Wilmington Pike in Centerville.

As part of its construction management contract, OTC provided services which included: the demolition of existing structures, the clearing of approximately 35 acres, the cutting and filling of 300K+ CY on 90 disturbed acres, and the construction of 2,500 lineal feet of public roadway. In addition, Oberer Thompson Company provided temporary utility services and construction access points for the wholesale retailer, Costco — the development's anchor tenant. OTC team members, Gene Tartell and Tony Quinter, accepted a commemorative framed photo on behalf of GDC, Ltd. from the Cornerstone Development Team.

Site improvements at Cornerstone began in January of 2014 and were substantially completed earlier this month.

To review safety for 2014, OSHA publishes a "Top Ten" list of the most cited violations.

# Top Ten OSHA Violations During 2014 include:

- 1. Fall Protection
- 2. Hazard Communication GHS
- 3. Scaffolding
- 4. Respiratory Protection
- 5. Powered Industrial Trucks
- 6. Lockout/Tagout
- 7. Ladders
- 8. Electrical, Wiring Methods
- 9. Machine Guarding
- 10. Electrical, General Requirements

The "Top Ten" list for 2014 is very similar to the list provided at the end of 2013. In fact, the top four violations stayed in the exact same order. After reviewing the "Top Ten" list, GDCG/OTC held an open discussion about its sixth installment of the Construction Bulletin. The Construction Bulletin is an informative tool to help all workers learn of items that have been witnessed or occurred on projects managed by GDCG/OTC.

The next safety meetings will be held in the first quarter of 2015.
