
# GREATER DAYTON CONSTRUCTION GROUP

### OBERER THOMPSON COMPANY FINALIZES RENOVATIONS AT INIDAN HILL HIGH SCHOOL

Oberer Thompson Company has substantially completed Phase I renovations at Indian Hill High School's Athletic Complex in Cincinnati, Ohio.

The first phase of a multi-phased project included: the demolition of existing ballfields, construction of baseball and softball fields (with synthetic turf infields), irrigated outfields, batting cages, masonry dugouts & backstops, and new scoreboards. The project scope also included the addition of grandstands located behind the backstops, a multi-purpose field, and a shot put / javelin pit.

Phase II of the project is scheduled to include renovations to the concession stands and softball and baseball field's pressboxes.

Over 300 holiday cards were made/signed and will be delivered to the Dayton VA Hospital by the Red Cross in mid-December.






### B&R DESIGNS LUXURY MASTER SUITE FOR LOCAL HOMEOWNERS
